Hriselna lam chungchang:

- Sahbawn leh Sanitizer te a awm tur ani
- Hmeichhe sanitary pads leh hnawmhne te paihna tur hmun  
ngaihtuahsak tur ani.
- Tawih thei leh tawih thei lo bawlhlawh paihna tur hmun hrang  
an siamsak tur ani.
- Tui chhe paihna tur an siamsak tur ani.

Ei leh in buatsaihna lam:

- Taksa tana tha eitur chaw, ni khatah vawi thum tal an hmu tur ani.

## Contract hnathawhna hmuna awm te tan:

# Engtiangin nge an chenna enkawl tur?

A thuphungin:

- Awlsam zawka camp enkawl a nih theihna ramdang atanga hnathawk a awm zinga malayalam tawng hria telin khawtlang hruguituten Committee an din ang.
- Ram dang atanga hnathawk a awm te nen tha taka an thawhho theihnan Malayalam leh tawng dang thiam an thlang tur ani
- Local Self-government te tanpuina in, ei leh in leh mamawh dangte chu khawtlanga mi in phal te leh he committee te hian an ngaihtuah sak thin tur ani.

# Engtiangin nge an chenna enkawl tur?

Ei leh in lam:

- Kerela mi te nen an ei leh in duh zawng a in ang lo a nih chuan, an chenna tur siamsakna hmunah khan an eitur te buatsaih sak mai tur ani.
- Atta, Dal, Purun, tel etc. te chu ngaih pawimawh sak hmasak tur a ni a, bungraw mamawh dnag te leh eirawngbawlna gas chu civil supplies, consumer fed, horti corp etc atangin an dil tur ani.
- An zing atangin eirawngbawl thiam an awm chuan, an chenna hmun a awm te ei leh in siam chu an thawk mai tur ani.

# Engtiangin nge an chenna enkawl tur?

Sum hmandan tur:

- An chenna tur sakna te, an ei leh in man tur te leh mamawh dang te chu State Disaster Response Fund (SDRF) “2245-05-101-94 FLOOD OTHER ITEMS” in a tum vek ang. Nikhata sawrkar sum an hman theih zat chu, puitling tan Rs 60/- leh Rs 45/- hu ang zel a ni ang.
  
- Heng an pawisa hmanna zawng zawngte hi felfai taka vawnthat tur a ni a, thil an leina lehkha/receipt te hmangin District thuneitute hnenah an bill leh thei ang.

# Engtiangin nge an chenna enkawl tur?

Hriselna lam:

- Kar khatah vawikhat tal Health Worker in an chenna hmunah kal in, an hriselna te an endik sak thin tur ani.

Hmalakna endik dan tur:

- Heng hmalakna zawng zawng te hi Health, Police, Labour & Revenue Department te nen tang kawpin vil reng tur ani.

# Engtiangin nge an chenna enkawl tur?

Harsatna/Buaina thlen dan tur:

- Heng ramdang atanga hnathawk a rawn awm te hian an chen lailawkna hmun hma emaw, ei leh in thu hla ah emaw, thil dang dangah te harsatna emaw sawisel duh nei ten awlsam taka an sawichhuah ve theih na Local Self- government in helpline number an buatsaih tur ani.

# Engtiangin nge he hri laka an inven dan tur kan in hrilh hriat ang?

- Mi tlawmngai te hmangin BREAK THE CHAIN campaign neih
- An tawng hman ngei a hri leng laka inven dan tur thuзиак chu an chenna hmuna tarchhuah.

- Village Council emaw Local Council te chuan an chen lailawkna tur an ruatsakna hmunah mimal zalenna (human rights value) an ngai pawimawhin, hrileng darh zel tur ven dan an zirtir ngei tur ani.
