### Scope of the Work

The present work is to reactivate the existing Floating Dome Model Biogas Plant installed at the KILA Canteen area. The firm / contractor has to rectify and repair all the damages and defects, clean all the blockages and replace fittings as necessary (stove and piping not included). Before submitting the quotation, the bidder must inspect the plant and ascertain its present condition. The entire quote shall form an integrated system.

## **Terms and Conditions:**

- 1. The Bidder shall quote the price in clear terms. The rates quoted must be inclusive of all taxes, cost of supply at site, onsite warranty and other charges if any.
- 2. The price should be quoted only in Indian rupees. The bid shall be typed and signed by the bidder.
- 3. Interested firm/contractor can inspect the plant on working day between 10.30 to 4.30 pm.
- 4. Validity: The Bid will be valid for 30 days from its date of opening. Further extension can be done by mutual consent.
- 5. The selected bidder shall execute an agreement in the Non-Judicial Stamp paper worth Rs. 200/- after remitting a security deposit of Rs. 5000/-
- 6. Commissioning: The damages of existing 2 numbers of 6m3 Biogas Plants installed at KILA canteen premises should be rectified in all respects and reactivated.
- 7. Payment: KILA will release the payment only after inspecting the plant and after becoming satisfied the work done is as per the requirements. The payment will be made after successful completion of the work and against proper invoice.
- 8. Warranty/: The warranty period of the work is one months. The Firm shall guarantee to repair the plants which found defective within the warranty period. The entire expenditure for repair the item in this regard shall be borne by the firm. warranty shall be on site and is applicable for the entire item.
- 9. Forfeiture of Security Deposit: The Security Deposit will be forfeited if the firm fails to complete the work as per the Work order. No payment will be made for any part of the completed works in the event of failure of the bidder to complete the work.
